



License Agreement

Read before you use this EJCDC document:

1. **Acceptance by use.** By accessing, downloading, copying, or otherwise using Engineer Joint Contract Documents Committee (EJCDC®) Design-Build Series Documents (Document(s)), you (Licensee) accept this License Agreement (Agreement). If you do not accept, do not use the Document.

The terms of the Agreement remain in effect regardless of whether it has been removed or remains attached to the Document. This Agreement applies to the Document only. Other EJCDC Documents may be subject to different terms.

2. **Definitions.**

- (a) “Covered Projects” means a Project that began during this Agreement’s base term (before the earlier of the Agreement’s expiration or the Revision Release Date). A Project is deemed to have “begun” after your purchase of the Document and any of the following first occurs:
 - (1) the Document (or a derivative) is issued to an owner, design-builder, consultant, proposers/bidders, design professional, or similar Project Participant to invite, solicit, or otherwise encourage their participation in the Project;
 - (2) a solicitation, request, or advertisement based on, incorporating, or relying on the Document is publicly or privately released; or
 - (3) a contract based on, incorporating, or relying on the Document is executed by any party.
- (b) “Design-Build Series” means The EJCDC Design-Build (D-Series) documents.
- (c) “Project” means a specific, bona fide procurement, contract, or undertaking by Licensee (as owner, design-builder, consultant, proposer/bidder, design professional, or similar role).

- (d) “Project Use” means the use of the Document solely for developing, soliciting, negotiating, administering, or performing a Project, including controlled distribution to bona fide participants in that Project.

- (e) “Revision” means the release of a new edition of either the specific Document you purchased or the Design-Build Series as a whole by EJCDC which supersedes the edition of your Document.

- (f) “Revision Release Date” means the first public release date of a Revision.

- (g) “Secure Distribution” means access limited to intended recipients by authentication, password, access-controlled links, private portals, or similar means—not publicly accessible, indexed, or scrappable.

3. **Grant of Limited, non-exclusive, non-transferable license.** Subject to this Agreement, EJCDC grants the Licensee a limited, non-exclusive, non-transferable license to:

- (a) Install and copy the Document within the Licensee’s organization on any number of devices under Licensee’s control.

- (b) Use and modify the Document for Project Use.

- (c) Distribute the Document for Project Use (only): Licensee may transmit the Document, in editable or read-only form, to bona fide Project participants (e.g., owners, proposers/bidders, subcontractors, sureties) via Secure Distribution.

All rights not expressly granted are reserved.

4. **Ownership; Notices.** The Document and all EJCDC® Design and Construction Related Documents are protected by U.S. and international copyright laws. Title

and all intellectual property rights remain with EJCDC® and its sponsoring organizations.

Licensee must include an EJCDC® copyright notice on any Project-specific draft, modified version, or excerpt:

If revisions are minimal:

If revisions are extensive, or only portions are used:

This document is a MODIFIED version of EJCDC® [Document No.], Copyright © [year] by the National Society of Professional Engineers, American Council of Engineering Companies, and American Society of Civil Engineers, or is based in part on excerpts from EJCDC® documents. Those portions of the text that originated in published EJCDC® documents remain subject to copyright.

5. **Permitted uses.** Licensee is limited to Project Use. Without limiting the generality of the foregoing, the following are permitted:

- (a) Editing in standard desktop software (e.g., Microsoft Word) and use of ordinary document features (styles, fields, auto-numbering, mail-merge) to prepare Project-specific drafts.
- (b) Inclusion of selected clauses from the Document within a broader Project contract package.
- (c) Controlled posting on a private procurement portal or within a Licensee-controlled document management system with Secure Distribution to bona fide proposers/bidders and other Project participants.

6. **Prohibited uses.** Licensee shall not:

- (a) Resell, republish, publicly post, or otherwise make this Document (in whole or part) on an uncontrolled or public-access website, repository, or other location accessible without Secure Distribution (no indexing, scraping, or open sharing).
- (b) Sublicense, assign, or transfer the Document or this license, except as expressly permitted

by EJCDC in this Agreement or in a separate license agreement.

- (c) Use the Document for non-Project purposes, including building generalized clause libraries, forms banks, or “house” templates for use outside specific Projects.
- (d) Use the Document to compete with EJCDC®, including creating substitute templates or derivative works offered to third parties as a product or service.

7. **Artificial intelligence, machine learning, and other automated tools.**

- (a) *Absolute training ban.* The Document, any modified version, and any excerpt may not be used to train, tune, augment, or otherwise inform any machine learning, large language model, embedding/vector database, or similar AI system—whether by direct ingestion, fine-tuning, RAG/embedding, prompt-based learning, or any other technique.
- (b) *No inputting Document text into generative tools.* Licensee shall not input, upload, paste, transmit, or expose Document text (including modified versions or excerpts) to any generative AI tool or automated drafting system (including SaaS or API-based services) except as expressly allowed elsewhere in this Agreement. You are not permitted to subject EJCDC intellectual property in any way that may result in the same being included in any model outputs or derivative outputs that replicate or paraphrase Document content.
- (c) *No automated drafting platforms for generalization.* Licensee shall not use the Document within contract automation, template managers, clause libraries, or similar tools (on-premises or SaaS) where the Document text would be stored, indexed, or made available other than as a single Project-specific working file for the Project at hand.
- (d) *Narrow safe harbor for internal tooling.* The following limited use is permitted: Project-specific editing within internally controlled software (including local document assembly/macros) provided that (a) the Document text is not exposed to any model, embedding store, or tool corpus which may learn, train, tune, augment, search, or otherwise retain Document text or content

otherwise prohibited by this Agreement; (b) there is no training, tuning, or retention for purposes beyond the specific Project; and (c) no third-party vendor obtains rights to reuse Document content.

- (e) *Vendor and IT controls.* If Licensee uses third-party services for storage, hosting, collaboration, document management, security scanning, or translation, Licensee must ensure—by contract or configuration—that Document content is not used for model training or service improvement and is not retained beyond Licensee’s permitted purposes.
- (f) *Injunctive relief.* Licensee recognizes that use of the Document in violation of this Agreement causes irreparable harm and, therefore, EJCDC is entitled to equitable relief in addition to all other remedies

8. **Distribution, delivery, and access.** EJCDC may deliver the Document by download, secure link, license key, or through a secure document platform or portal. EJCDC may transition delivery methods over time while preserving Licensee’s access to the purchased edition for the remaining license term.

Licensee must use Secure Distribution for all sharing. Public posting—whether with or without watermarks, whether in Word, PDF, or any other format—is prohibited.

9. **Term.**

- (a) *Base term.* Licensee may use the Document under this Agreement for a base term of three years from the date of purchase. Except as provided elsewhere in this Agreement, and unless terminated earlier, this Agreement and Licensee’s right to use the Document (including any Revision) terminates at the conclusion of the base term.
- (b) *Extended term.* At EJCDC’s sole discretion, it may extend the term of this Agreement by notifying you, in writing, or by publishing an extension on the ejcdc.org website or the websites of the National Society of Professional Engineers, American Council of Engineering Companies, and American Society of Civil Engineers.
- (c) *Effect of Revision.* Upon a Revision Release Date, subject to permission to use the Document for Covered Projects provided

elsewhere in this Agreement, (1) Licensee may not initiate any new Project using the superseded edition; (2) Licensee’s right to use the superseded edition terminates as of the Revision Release Date; and (3) at no additional charge, Licensee may obtain (by written request to EJCDC) the Revision and may use that Revision for the remainder of the unexpired base term (including any extension thereof), and may initiate new Projects using the Revision during that unexpired portion of the base term. The issuance of a Revision does not extend or reset the base term.

10. **Continued use beyond the base term for existing projects.**

- (a) *Permitted continued use.* For Covered Projects, Licensee may continue to use the Document (as edited for that Project) after the expiration of the base term through Project completion and closeout as reasonably necessary to conclude that Project.
- (b) *No new Projects or generalization.* After the expiration of the base term or earlier Revision Release Date, Licensee shall not start any new Project based on the Document or superseded edition and shall not transform Project-specific edits of the superseded edition into generalized forms or libraries.
- (c) *Archival copies.* Upon expiration of the base term, Licensee may retain archival copies in its files for recordkeeping, claims, and compliance.

11. **Educational use.** Educational use (e.g., classroom distribution, training materials, and similar use) requires advance written permission from the EJCDC and may be subject to additional terms.

Limited warranty; remedy. If EJCDC supplies a corrupted or inaccessible download or access credential, EJCDC will provide a replacement download or access credential. This is your sole and exclusive remedy. The Document is provided as is without any express or implied warranties, including warranties of merchantability, fitness for a particular purpose, or non-infringement. EJCDC does not warrant that the content or functions contained in the Document will meet your requirements or that the operation of Document will be uninterrupted or error free.

12. **Assumption of risk and limitation of liability.** EJCDC provides the Document and other construction related documents and licenses their use worldwide. You assume sole responsibility for the selection and use of

the Documents or use of other information provided by EJCDC, or portions thereof, to achieve your intended results, and for the installation, use, and results obtained from EJCDC Design and Construction Related Documents. You acknowledge that the text of the Document has important legal consequences and that consultation with an attorney is recommended with respect to use or modification of the text.

EJCDC allows the end user wide discretion in using and editing the attached document, subject to the provisions of this Agreement. You are advised, however, that EJCDC documents contain numeric and other cross-references, and that changes to one part of the document may affect other parts. It is solely your responsibility to assure the adequacy and consistency of the final document for your purposes.

To the fullest extent permitted by law, EJCDC, its sponsoring organizations (American Society of Civil Engineers, National Society of Professional Engineers, and American Council of Engineering Companies), committee members, attorneys, consultants, vendors, and advisors shall not be liable for any indirect, special, incidental, consequential, or economic damages (including lost profits, lost savings, disappointed commercial expectations, or contractual liabilities) arising out of the content, sufficiency, modification, or use of the Document. Some jurisdictions do not allow certain exclusions; in those jurisdictions, liability is limited to the amount paid for the Document.

13. **Assignment, successors, and remedies.** This Agreement and the license it conveys is personal to Licensee and may not be sublicensed, assigned, or transferred without EJCDC's written consent, except to a successor by merger or sale of substantially all assets, provided the successor agrees in writing to be bound by this Agreement. Any unauthorized transfer is void and terminates this Agreement. EJCDC's failure to enforce any provision is not a waiver. EJCDC may pursue all remedies at law and in equity, including injunctive relief.
14. **Termination.** This license terminates automatically upon (i) expiration of the base term (or any extension thereof or completion of a Covered Project), (ii) unauthorized transfer or conveyance of any rights or license created by this Agreement, or (iii) breach of this Agreement by the Licensee. Licensee may terminate at any time by destroying all copies (other than archival copies) and ceasing to use the Document. Upon termination or expiration, Licensee shall cease all non-Project use and destroy editable copies, keeping only archival records and copies embedded in contracts for Covered Projects.

15. **Governing law, notices, and completeness of Agreement.** This Agreement is governed by the laws of the Commonwealth of Virginia, without regard to conflict-of-laws rules. Questions and permission requests should be directed to EJCDC at the then-current contact information posted on ejcdc.org. This Agreement is the complete and exclusive statement of the license and supersedes all prior proposals and communications regarding the Document.
